- 5) As per Section 115BAA in the Income Tax Act, 1961, the company has an irrevocable option of shifting to a lower tax rate and simultaneously forgo certain tax incentives, deductions and accumulated MAT credit. The Company has not exercised this option for the financial year 2025-26 in view of the benefits available under the existing tax regime.
- 6) The Company sold 4,67,100 shares of its investment in associate M/s. The Ramco Cements Ltd., for a sale consideration of ₹4,040.07 Lakhs. The profit arising from this sale amounted to ₹ 1,689.70 Lakhs in Previous year (CY: NIL).
